

Mahidol University Regulation on Mahidol University Student Attire

B.E. 2564 (2021)

•••••

Whereas social changes in the current situation may cause inequality and discrimination in the society, it is deemed appropriate to revise Mahidol University regulation on Mahidol University Student Attire to make it more suitable for the changing teaching and learning styles and to become more consistent with Mahidol University Regulation B.E. 2550 (2007) and other related laws.

By virtue of Section 24 (2) and Section 67 of Mahidol University Act B.E. 2550 (2007), the Mahidol University Council, at its 565th meeting on 17 February 2021, issued the following regulations.

Clause 1 This regulation is referred to as "Mahidol University Regulation on Mahidol University Student Attire, B.E....."

Clause 2 This regulation shall come into force from the day after the announcement date onwards.

Clause 3 The Regulation on Mahidol University Student Attire B.E. 2553 (2010) shall be abolished.

Clause 4 According to this regulation,

"University" means Mahidol University.

"Working Unit" means a campus, a faculty, a college, and institute or the working units called otherwise under affiliation of the University where teaching and learning are provided in accordance with the programs set by the University.

"Head of Working Unit" means the dean, or the director of the working unit where teaching and learning are provided in accordance with the programs set by the University.

"Student" means students of the University who have enrolled for an entire program to study in the University's or its working unit's program.

"Short-term Undergraduate Student" means

- (1) An exchange student who is an undergraduate student of the partner university that has made an academic agreement known as MoU/MoA Agreement with the University. According to this agreement, an exchange student can come to study or conduct research at the University as the host university for at least 1 semester with enrollment and exemption from the University tuition fees.
- (2) A visiting student is an undergraduate student of a foreign university coming to study or to conduct research at the University as the host university for at least one semester with enrollment and payment for the University tuition fees.
- (3) A special project student is an undergraduate student of a foreign university coming to study or exchange knowledge; do research, pay a study visit, attend an internship; or participate in training, an activity or a project under the supervision of Office of the President or a working unit without registration.

"Affiliated Institute Student" means a student of an affiliated institute under Mahidol University Regulation on Affiliated Institute only the program that is taught at the University.

"Co-teaching Institute Student" means a student of a co-teaching institute of the University only the program taught at the University.

"Attire" means student attire consisting of a shirt, a pair of pants or a skirt, a pair of shoes, a pair of socks and University badges including a brooch, a buckle, a necktie, or a bowtie with the University emblem.

"Gender Identity" means the nature of a person or the person's identity including the mind and behavior exhibited regarding the person's gender.

"Gender" means the behavior, conduct, or gender roles of the person that may not match the gender of origin.

Clause 5 The President shall be the person in charge of this regulation.

In case of any problem in compliance with this regulation, the President shall be empowered to make a judgement and give the order that shall be regarded as final.

Chapter 1

General Provision

Clause 6 There are 2 types of student attire

- (1) Regular Uniform
- (2) Formal Uniform

Clause 7 Student attire shall be worn only by those who have the status of the University's student.

Clause 8 Short-term undergraduate students, affiliated institute students and co-teaching institute students are eligible to wear student uniform during class at the University.

Clause 9 Students may wear the student uniform according to their gender identity or gender that does not match the gender of origin in compliance with this regulation.

The dress codes under Paragraph 1 shall include the dress codes for the commencement ceremony.

Chapter 2

Regular Uniform

Clause 10 Students may wear regular uniform during the time for class, examinations, workshops, or contact with a working unit of the University.

Clause 11 Regular uniform of male students consists of

- (1) Short or long-sleeved plain white shirt with its hem below the hip and neatly tucked in the pants
- (2) Plain black, dark blue or navy blue pants, not low-rise pants
- (3) Black or brown leather or suede belt and rectangular silver metal buckle with gold University badge
- (4) Black, blue, gray or brown socks
- (5) Black or non-colorful shoes

Clause 12 Regular uniform of female students consists of

- (1) Plain white shirt as described:
 - (1.1) Made from fairly thick fabric
 - (1.2) With its hem below the hip and neatly tucked in the skirt
 - (1.3) With a front slit attached with white plastic buttons and not too tight
 - (1.4) Short sleeves above the elbow
- (2) University brooch pinned on the right side of the shirt
- (3) Modest plain black, dark blue or navy blue skirt with suitable length
- (4) Black or brown leather or suede bell and rectangular silver metal buckle with gold University badge

(5) Black or non-colorful shoes or strap back shoes

Clause 13 A Muslim female student may wear the attire under Clause 12, or the following attire.

- (1) White blouse with long sleeves and buttoned cuffs
- (2) University brooch pinned on the right side of the shirt or headscarf
- (3) Modest plain black, dark blue or navy blue straight skirt with ankle length
- (4) Plain religious headscarf
- (5) Black or brown leather or suede belt and rectangular silver metal with gold University badge
- (6) Black or non-colorful shoes or strap back shoes as appropriate and modest

Clause 14 A working unit has the right to prescribe additional dress code as appropriate based on the nature of teaching and learning. This shall be issued as an announcement of the working unit, but the prescription of such dress code shall not lead to discrimination.

Chapter 3

Formal Uniform

Clause 15 Formal uniform shall be worn in ceremonial occasions of the University, such as New Student Orientation, Wai Kru, Commencement Day, state ceremony, or as prescribed by the University.

Clause 16 Formal uniform of male students consists of

- (1) Long-sleeved plain white shirt with its hem below the hip and neatly tucked in the pants
- (2) Navy blue necktie with University badge
- (3) Plain dark blue or navy blue dress pants; not low-rise pants
- (4) Black leather or suede belt and rectangular silver metal buckle with University badge
- (5) Plain black socks
- (6) Plain black leather dress shoes in simple design

Clause 17 Formal uniform of female students consists of

(1) Plain white shirt as described

- (1.1) made from fairly thick fabric
- (1.2) With its hem below the hip and neatly tucked in the skirt
- (1.3) With a front slit and a placket attached with white plastic buttons
- (1.4) short sleeves above the elbow
- (2) University brooch pinned on the right side of the shirt
- (3) University bowtie with University badge
- (4) Modest straight dark blue or navy blue skirt with overlapped back slit and its length below the knees
- (5) Black or brown leather or suede belt and silver metal buckle with gold University badge
- (6) Simple-designed plain black leather shoes

Clause 18 A Muslim female student may wear the attire under Clause 17 or the following attire.

- (1) Long-sleeved white blouse and button cuffs
- (2) Modest ankle-length plain dark blue or navy blue skirt
- (3) Plain religious headscarf
- (4) University brooch pinned on the right side of the blouse or the headscarf
- (5) Black leather or suede belt and rectangular silver metal with University badge
- (6) Simple-designed plain black shoes
